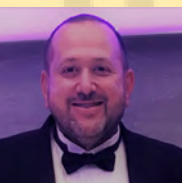

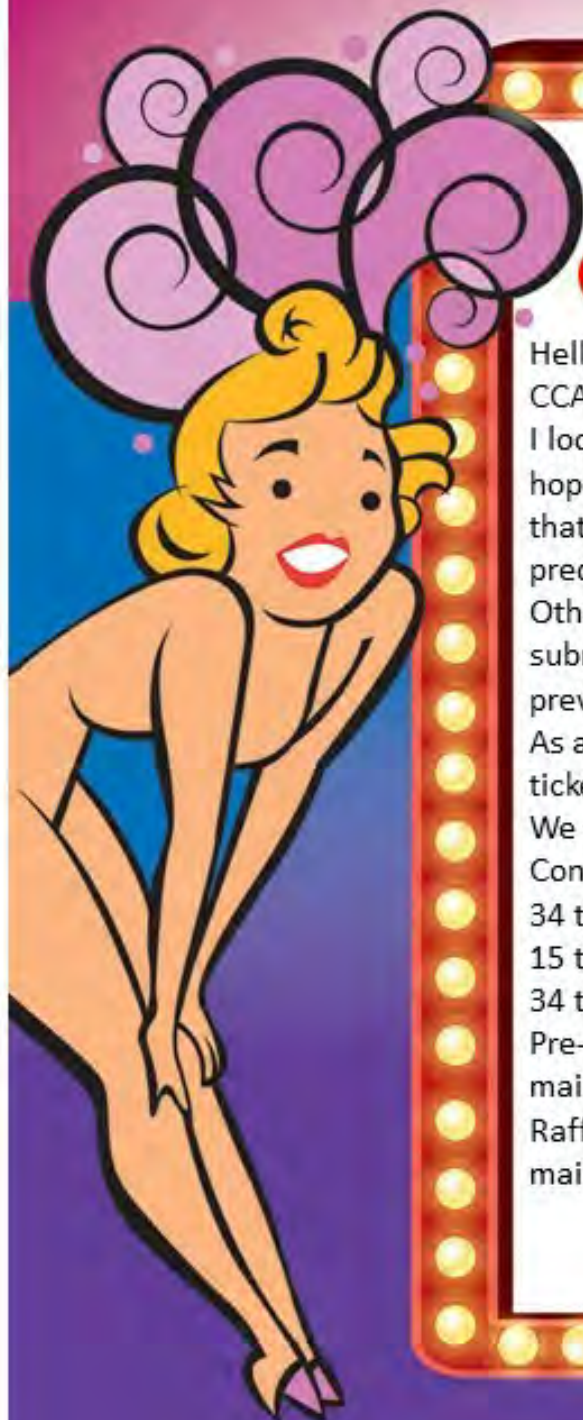

Total Items on ChipGuide is 300,118 as of 31 September, 2022

You can help the MoGH achieve greater success in our efforts to add more content to ChipGuide. Do you have casino memorabilia and related collectibles that are not in ChipGuide? If so, we encourage anyone, Club member or not, to submit images and descriptions of such items to ChipGuide via this [Submission](#) link.

As noted above, we have now surpassed the 300,000 uploaded images to ChipGuide. When this happened on the 28th of September, it was noted in a posting on TheChipBoard, by Charles Kaplan, ChipGuide Webmaster and MoGH Chairman:

"The ChipGuide now has over 300,000 items in its database. Thanks to all of the Contributors and to all of the Admins who made this possible. Entirely volunteer work by all, an amazing accomplishment and what makes this hobby the best."

There were several reply posts there of Congratulations, including this quote from ChipGuide Admin, Eric Miller: "Thanks to all involved! Greg would have been proud!"

Yes, Greg Susong would have been proud as ChipGuide was Greg's inspiration and creation. It was part of what earned him induction into the Club's Hall of Fame.

Here is a rundown of the ChipGuide Admins and Submitters:

Over the years, there have been 1, 386 individual Submittters/Contributors to ChipGuide.

There are currently, 26 ChipGuide Admins. ChipGuide Admins process contributions/submissions to the ChipGuide. They are responsible for the content throughout ChipGuide. They research casinos and chips, and other collectibles, and make that information available on the ChipGuide. They do the best they can with the information available, but cannot always be 100% accurate. Users of ChipGuide may, and are encouraged to contact an Admin, if you have a concern about information presented on the ChipGuide or have some new information to share. This is typically accomplished by using the "Update" button when viewing any item on ChipGuide.

In the last issue, it was noted that the Trail of the MoGH's, Guinness World's Record "Largest \$1 Casino Chip and Token Collection" Exhibit, was temporarily moved from Spinnettis Gaming Supplies for exhibit at the SNCCC's Fall Chip Show. That relocation and return was accomplished and the Exhibit is now back at Spinettis.

We are also please to announce that the Exhibitor, Gregg Fisher, and Spinettis (Mikko Melander) have agreed to extend for 12 months, the display of the Exhibit. The MoGH thanks both Gregg

and Mikko for this extension to October 31, 2024 at Spinettis. For those who many not know, Spinettis offers a 10%, in-store discount, to CCA/MoGH members. As a Trail of the MoGH partner, we thank them for that.

Over 2 years ago the MoGH was presented with a wonderful opportunity to create 'Pop-Up Museums' at 7 Boyd Gaming casinos in Las Vegas as tributes to the Stardust Hotel and Casino, once owned by Boyd Gaming. At that time the MoGH put out a Call for Loaners (and donations) of Stardust artifacts to provide a Trail of the MoGH tall display case at each location with the loaned and donated artifacts. Several Club members made pledges of artifacts, while several others also provided artifacts as loaners or donations.

Back then, Boyd Gaming was about to introduce a social media casino site that was to be heavily presented to Boyd Gaming Player's Club members (B-Connected) at the casinos in Las Vegas and the pop-up museums were an element of the marketing plan. Unfortunately, the opening date was pushed back because of COVID, and even today it is stalled due to COVID concerns.

The MoGH has been holding those items for over 2 years now and very recently, one of the loaning individuals requested the return of artifacts and it was decided to do the same for all other individuals that loaned items to the MoGH for this Project.

Accordingly, all participants (loaners, donors and those that pledged) have been contacted to advise that while this Project may materialize in the future, for the present we are standing down and returning loaned items. Without specifying who loaned, who pledged and who donated, the MoGH Board wishes to acknowledge those who supported this effort.
