This the annual meeting of the Corporation held on June 14th, 2025, held on CCA Annual Meeting,, for the purposes of reviewing the prior six months business, discussing corporate operations for the up coming year, and for the transaction of any other business that may properly come before the meeting

Membership Report

Jay gave the membership report and told the room:

- We have currently 907 Members
- We have seen the membership reduce by 80 members since the last meeting
- Since we began the club we have had over 300 members die, but the information was very difficult to get as record keeping has not always been accurate.

Financial Report

MoGH Report

Charles gave a verbal report to the room as he had not brought his notes from the MoGH board meeting.

In general there are two main developments:

- The MoGH was now looking at a physical location possibility due to the addition of a new board member. She has great contacts and is really helping the club to move forward.
- That there are changes coming to the Chip Guide, members of the CCA and MoGH will still have access to all of the functions of the Chip Guide but non members will not. They will be encouraged to become members of the CCA.
 - o Non members will not be able to access items like the search functions.
 - They will not be able to trade or do the "my collection"
 - o New features developed would also be restricted to members only
 - This change will happen on 1st August 2025

- 2. It will also act as a registration mechanism for the convention, poker tournament, and other activities we may undertake. Tracking and reporting will be much easier.
- 3. Provide avenues of engagement for members to more directly help implement improvements to the club. In other words, find more ways for members to volunteer and seek out members willing to help out who have not previously done so.
- 4. Provide incentives to new members
- 5. Provide incentives for referrals by existing members.
- 6. Take a comprehensive inventory of all CCA & MOGH assets and donations. I'm starting this project on Sunday, June 22, and if you will be in town that week, I'd love to have your help.
- 7. Sell undesignated donations in auctions to raise funds.
- 8. Give away donated items as incentives to join the club.
- 9. Figure out what to do with the club library. Digitize everything to start with. See if it's feasible to continue an online lending library. If not, donate the library to a brick & mortar library.
- 10. Make all regular board meetings open to the membership via zoom. Executive sessions that require discretion will be excluded from public participation.
- 11. Distribute meeting minutes within 48 hours on the club website, with links to same published on various social media outlets.
- 12. Set up a cloud based repository to store all club knowledge, files, and electronic assets, with various levels of access for board members, committee, chairs, general members, and the public.
- 13. Implement an acceptable, long-term mechanism for distributing the club magazine, newsletters, and other forms of communication. This is probably one of the most contentious action items I intend to delve into. My favored option is to distribute the magazine electronically to everyone, but also upload the magazine to a one-off publishing company where anyone interested in getting a copy in the same format as it's currently distributed can do so on their own at their own expense. This will save the club tens of thousands of dollars per year.
- 14. And finally, do all of the above with love and care for the club and its members to ensure that the club remains viable and thriving long into the future.

If you are called on to pitch in, either with your knowledge or labor or finances, I hope we can count on you. A great many of you have already approached me, shaken my hand, congratulated me, and offered your assistance. I am grateful to witness so many have that attitude, and you can rest assured I will be taking you up on it.

I thank you for this opportunity. It's an honor to serve you and I hope to make you happy that I'm in this seat.

There were comments that the Poker tournament was not as good as it could have been and that we wanted to go back to the older format. This was agreed by all who were in it that attended this meeting. This will be discussed further after the Convention.

Final business: Barry appointed Mike Nawrock to the board as the new Membership Director: this received a round of applause from the room and Mike acknowledged this and gave his thanks.
