### AMENDMENTS TO CONSTITUTION

#### **A: LESS RESTRICTIVE NOTIFICATION REQUIREMENTS**

**Article 4, Section 3(B) shall be amended to read as follows:**

B) Nominations for officers shall be solicited by notification to all members in good standing not later than 180 days prior to the Club's next annual meeting in an election year. In order for a potential candidate to be declared an official nominee and listed on the ballot in any Club election for office, the candidate must receive a minimum of two nominations, which is the equivalent of a nomination and a second.

**Article 4, Section 3(C) shall be amended to read as follows:**

C) Election ballots, along with voting instructions, shall be made available to each Charter, Regular and Life member in good standing no later than sixty (60) days prior to an annual business meeting.

**Article 4, Section 3(H) shall be amended to read as follows:**

Notification Methods - All communications, including notices, notifications, calls for nominations, ballots, or any other communication as the board and/or its authorized agents deem necessary, may be disseminated using one or more of the following distribution methods:

- (i) Delivery by mail via United States Postal Service;
- (ii) Inclusion in the club yearbook or any other printed document delivered by the United States Postal Service, either as bound copy, as an insert or otherwise;
- (iii) Delivery electronically, by email or other electronic method reasonably expected to be delivered to club members, either directly from an authorized account or by using an email management service (such as Constant Contact);

- (iv) Posting on the club's message boards; and
- (v) Posting to social media outlets reasonably expected to be frequented by club Members.

**The first paragraph of Article 6, Section 1 shall be amended to read as follows:**

This Constitution may be altered or amended. Alterations or amendments shall be presented in writing to the President who shall cause written notification to be provided to all members. Ballots containing any proposed alteration or amendment of this Constitution shall be made available to each member at least sixty (60) days prior to the annual business meeting, and shall specify the procedure for casting ballots. A two-thirds majority of those voting shall be required to amend.
